A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITTI DJALIA TURABIN HATAMAN, CITY MAYOR, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF HEALTH REGION-IX, ZAMBOANGA PENINSULA CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY EMILIA P. MONICIMPO, MD, MPH, CSEE, REGIONAL DIRECTOR, IN THE GRANT OF ACTIVE HAZARD PAY AND SPECIAL RISK ALLOWANCE.

WHEREAS, the whole nation was declared under the State of Public Health Emergency through Proclamation No. 922 s. 2020, to combat the threat brought by Corona Virus Disease 2019;

WHEREAS, the Office of the President issued Administrative Order Nos. 35 and 36, authorizing the grant of Active Hazard Pay (AHDP), to Human Resources for Health (HRHs) and Special Risk Allowance (SRA), to private and public health workers directly catering in the frontlines during the State of National Emergency;

WHEREAS, the grants will enable all health workers to cope up and recover from the effects of the pandemic mentally, physically, emotionally and financially that will boost their morale to continue fighting in the frontlines.


NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**
