A RESOLUTION ADOPTING THE ISABELA DE BASILAN CULTURAL HERITAGE INVENTORY, INITIALLY GATHERED BY THE CITY TOURISM OFFICE, WHICH DOCUMENTS THE VARIOUS TANGIBLE, INTANGIBLE AND NATURAL TYPES OF CULTURAL HERITAGE PREVALENT IN THE CITY OF ISABELA.

WHEREAS, Section 2 of Republic Act No. 10066, otherwise known as the “National Cultural Heritage Act of 2009,” mandates the protection, preservation, conservation and promotion of the nation’s cultural heritage, its property and histories, and the ethnicity of local communities. Sections 14(b) and (c) of the said Act requires local government units to establish and maintain an inventory of cultural property while Section 16 of this Act directs LGUs to document and preserve the traditional and contemporary arts present within its jurisdiction;

WHEREAS, the Isabela de Basilan Cultural Heritage Inventory shall be submitted to the National Commission for Culture and the Arts (NCCA) for inclusion in the Philippine Registry of Cultural Property (PRECUP) which is a registry of all cultural properties of the country deemed important to its cultural heritage and serves as a repository of the nation's dynamic culture for development, promotion and dissemination;

WHEREAS, the City Tourism Office has initially gathered, compiled and documented several tangible, intangible and natural types of cultural heritage in the City of Isabela. It details the background, type/nature of heritage, description, significance, location, conservation status preparatory to the conduct of more detailed cultural mapping.

NOW WHEREFORE, upon motion of Councilor Bimbo E. Epping, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, adopts the Isabela De Basilan Cultural Heritage Inventory, Initially gathered by the City Tourism Office, which documents the various tangible, intangible and natural types of cultural heritage prevalent in the City of Isabela.


