WHEREAS, Isabela City Police Office is manned with 163 more or less police personnel mandated to serve and protect the constituents of Isabela City;

WHEREAS, with the growing populace of Isabela City, the Isabela City Police Station is undermanned as to police and constituent ratio, thereby resulting in setbacks in police visibilities and providing protection to the forty (45) barangays of the City;

WHEREAS, the conversion into an office, additional police personnel will be poured out in the police force thereby giving the capability to effectively serve and protect the city and its inhabitants.

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, requests Police General Debold M. Sinas, Chief, Philippine National Police, through the Regional Director, Police Regional Office IX, Pagadian City, the conversion of Isabela City Police Station into Isabela City Police Office,
