**EXECUTIVE ORDER NO. 03**

**AN ORDER REORGANIZING THE CITY NUTRITION COMMITTEE (CNC) AND THE CNC TECHNICAL WORKING GROUP (CNC-TWG) OF THE CITY OF ISABELA.**

**WHEREAS**, Sections 16 & 17, R.A. 7160 otherwise known as the Local Government Code of 1991 empowers every local government unit to ensure and support the promotion of public health and safety of its inhabitants and to provide them with basic services and facilities including nutrition services;

**WHEREAS**, Letter of Instruction 441 of 1976 instructs various departments of government to address malnutrition and authorizes the Department of Interior and Local Government (DILG) to establish functioning committees at different administrative levels;

**WHEREAS**, DILG Memorandum Circular No. 2012-89 dated May 14, 2012 directs the reorganization and strengthening of a functional Local Nutrition Committee;

**WHEREAS**, DBM Local Budget Memorandum No. 78 dated May 15, 2019 reiterated the DILG Memorandum Circular No. 2018-42 dated March 26, 2018 enjoining all LGUs to prioritize in the allocation of local funds the PPAs included in their local nutrition action plans, which shall be formulated in accordance with the Philippine Plan of Action for Nutrition 2017-2022;

**WHEREAS**, a Committee on Nutrition was created in Isabela City that is responsible for nutrition program management and is consistent with the requirements of the nutrition program of the government in response to the declining nutritional status in the different local government units including the City Government of Isabela;

**WHEREAS**, recent development necessitates the reorganization of the City Nutrition Committee (CNC) and its working arm/secretariat, the CNC Technical Working Group (CNC-TWG), to further strengthen and facilitate the implementation of the Nutrition Programs.

**NOW THEREFORE, I, SITI DJALIA T. HATAMAN**, the Mayor of Isabela City, by virtue of the powers vested upon me by law, do hereby order as follows:

**SECTION I. REORGANIZATION OF THE CITY NUTRITION COMMITTEE (CNC).** The composition of City Nutrition Committee is hereby reorganized as follows:

**SECTION II. DUTIES AND FUNCTIONS OF THE CNC.** The CNC shall have the following duties and functions:

- a) Integrate the City Nutrition Action Plan (CNAP) complementary to and integrated with other plans of the LGU and other concerned agencies;
- b) Advocate the adoption and financing of the CNAP;
- c) Coordinate and monitor nutrition and nutrition-related activities of member agencies and other agencies;
- d) Mobilize resources to ensure the CNAP is implemented;
- e) Conduct periodic meetings and trainings with the Nutrition Committees (BNCs);
- f) Provide technical assistance to the component Barangays;
- g) Monitor performance, assess progress of plan implementation and recommend appropriate actions;
- h) Hold regular quarterly meetings to assess plan implementation; and
- i) Introduces innovation in the management of nutrition programs.

The City Nutrition Program Coordinator/s shall act as Coordinators/Facilitators of the CNC-TWG.

**SECTION III. REORGANIZATION OF THE CITY NUTRITION COMMITTEE TECHNICAL WORKING GROUP (CNC-TWG).** The composition of City Nutrition Committee Technical Working Group is hereby reorganized as follows.
