**EXECUTIVE ORDER NO. 04**

**CREATING THE LOCAL VERIFICATION COMMITTEE FOR NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION OR LISTAHANAN IN THE CITY OF ISABELA, PROVINCE OF BASILAN**

**WHEREAS**, Executive Order No. 867, Series of 2010 issued on March 9, 2010 provided for the adoption of the National Household Targeting System for Poverty Reduction (NHTSPR) as the mechanism for identifying poor households who shall be recipients of social protection programs nationwide.

**WHEREAS**, the NHTSPR, now called LISTAHANAN, aims to have a database of poor, near-poor and non-poor households in the country;

**WHEREAS**, the Department of Social Welfare and Development is primarily tasked with the implementation of the LISTAHANAN in local government units concerned.

**WHEREAS**, there is a need to organize a Local Verification Committee at this city level to address various concerns regarding the LISTAHANAN, particularly in its validation and finalization phase.

**NOW, THEREFORE, I, SITTI DJALIA A. TURABIN-HATAMAN**, City Mayor of Isabela de Basilan, by virtue of the powers vested in me by law, do hereby ORDER.


**Section 1.** *Creation of the Local Verification Committee* - the LOCAL VERIFICATION COMMITTEE in the City of Isabela de Basilan, hereinafter referred to as the Committee, is hereby created, to be composed of the following:

**Section 2. Duties and Functions of the Committee** -The Committee shall perform the following duties and functions:

- a) Resolve all complaints and/or appeals brought by individuals or group involving the LISTAHANAN.
- b) Identify households that have not been assessed based on complaints and appeals received.
- c) Certify the completeness or incompleteness of the List of Households living below the poverty threshold along with the recommended changes.

**Section 3. Repealing Clause** - All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

**Section 4. Effectivity Clause** - This Executive Order shall take effect immediately.
