AN ORDER DESIGNATING MR. ALBINO B. ORBECIDO, ENVIRONMENTAL MANAGEMENT SPECIALIST II, AS THE FOCAL PERSON FOR THE OPAPP-PAMANA PROGRAM IN THE CITY OF ISABELA, BASILAN.

WHEREAS, it is the earnest intent of the Government to strengthen the peace-building, reconstruction and development in the conflict-affected and vulnerable areas and to sustain socio-economic stability among its residents;

WHEREAS, the Office of the President Adviser on the Peace Process, in connection with its mandate to oversee the comprehensive peace agenda of the government and to monitor the effectiveness of reform, is implementing the Payapa at Masaganang Pamayanan (PAMANA) Program;

WHEREAS, the City Government of Isabela has entered into a Memorandum of Agreement with the office of the Presidential Adviser on the Peace Process for the effective facilitation of one FY 2017 PAMANA PROGRAM;

WHEREAS, the PAMANA Program can be efficiently and effectively implemented through the designation of a capable person to personally coordinate, put into operation and execute the program;

NOW THEREFORE, I, SITTI DJALIA TURABIN-HATAMAN, by virtue of the power vested in me by the Local Government Code of 1991, and other existing laws, hereby order the DESIGNATION of 'MR. ALBINO B. ORBECIDO' as the Focal Person for the OPAPP-PAMANA Program.

Section 1. DESIGNATION OF THE OPAPP-PAMANA PROJECT FOCAL PERSON -The OPAPP-PAMANA Program shall have a Focal Person who shall lead in the implementation of the Project and the related-activities.

Section 2. DUTIES AND RESPONSIBILITIES OF THE OPAPP-PAMANA PROGRAM FOCAL PERSON- the Focal Person shall:

1. Oversee the necessary requirements for the implementation of the project;
2. Prepare and submit necessary reports as stipulated in the Memorandum of Agreement; and
3. Other functions as may be necessary for the implementation of the program.

Section 8. EFFECTIVITY CLAUSE- This Order shall take effect immediately.
