AN ORDINANCE AMENDING SECTION 5(m), OF ORDINANCE NO. 20-584, PRESCRIBING THE CURFEW HOURS WITHIN THE TERRITORIAL JURISDICTION OF ISABELA CITY.

WHEREAS, the economic recession that resulted from the pandemic struck the country several setbacks especially the business sectors suffering loss of incomes, gains and opportunities;

WHEREAS, to mitigate the effects of economic down flow, both the national and local government are finding ways and setting policies that will help economic recovery;

WHEREAS, a curfew hour from 11:00 p.m. to 5:00 a.m. is favorable to let small and medium enterprises to economically recover from the economic recession being experienced by many.

SECTION 1. AMENDMENT. Section 5(m), of Ordinance No.20-584, prescribing the curfew hours from 11:00 p.m. to 5:00 a.m., in the City of Isabela.

SECTION 2. EFFECTIVITY. This Ordinance shall take effect immediately.


