AN ORDINANCE AMENDING FURTHER SECTION 10(g), ONE-WAY STREETS, OF ORDINANCE NO. 03-143, OTHERWISE KNOWN AS THE TRAFFIC CODE OF ISABELA CITY, THEREBY CLOSING TEMPORARILY FOR EIGHT MONTHS PORTION OF ULBERT ULAMA TUGUNG ROAD FOR THE RENOVATION PROJECT OF THE OLD PUBLIC MARKET.

WHEREAS, it is the policy of the state to ensure the safety and the well-being of the general welfare of the Isabeleños;

WHEREAS, the Department of Public Works and Highways through the City Government of Isabela, will be undergoing a major renovation of the Old Public Market;

WHEREAS, portion of Ulbert Ulama Tugung Road, from the junction of Barinaga Street to Shukran Store, shall be closed temporarily to be utilized as relocation site for the displaced stall owners of the old public market, in connection with the renovation of the old public market.

NOW WHEREFORE, upon motion of Councilor Jashim I. Tiplani, duly seconded by all member present, **BE IT**

SECTION 1. Section 10 – One-way Streets.

- a. N. Valderrosa Street-junctions with JS Alano St., Ext.
- b. Rizal Ave., - between its junction with N. Valderrosa St. and JS Alano St.
- c. Roxas Ave. - from its junctions with Gen. Alvarez St. to its intersection with Legaspi St.
- d. Barinaga St. – between its junctions with Roxas Ave. and Ulbert Ulama Tugung Road
- e. Legaspi St. – between its junction with Roxas Ave. and I. Magno Street.
- f. I. Magno St. – between its junction with Legaspi St. and Gen. Alvarez St. Ext.
- g. **Ulbert Ulama Tugung Road – closed from the junction of Barinaga St., to Shukran Store.**

SECTION 2. Effectivity. This Ordinance shall take effect immediately.
