AN ORDER RECONSTITUTING THE BIDS AND AWARDS COMMITTEE (BAC), BAC SECRETARIAT AND BAC TECHNICAL WORKING GROUP OF THE CITY GOVERNMENT OF ISABELA, BASILAN

SECTION IV. EX-OFFICIO MEMBER. The Head of the Requesting Department shall be an Ex-Officio member of the BAC without voting powers.

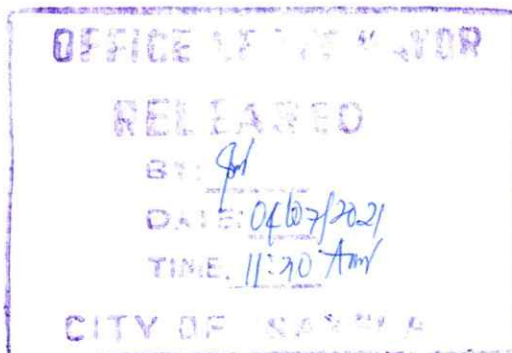
