AN ORDINANCE REALIGNING THE AMOUNT OF ONE MILLION SIX HUNDRED SEVENTY FIVE THOUSAND PESOS (P1,675,000.00), TAKEN FROM THE TOTAL SAVINGS OF THE PROJECT ESTABLISHMENT AND OPERATIONALIZATION OF CCTV EARLY WARNING SYSTEM, UNDER 5% LDRRMF AND UNDER THE 70% MITIGATION FUND, SAME BE RE-APPROPRIATED TO COVER PAYMENT FOR THE PROPOSED PROJECT ENTITLED "RELOCATION OF THE PUBLIC MARKET WIRELESS BASE STATION, ISABELA CITY, BASILAN.

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

Section 1. – The amount of **ONE MILLION SIX HUNDRED SEVENTY FIVE THOUSAND PESOS (P1,675,000.00)**, taken from the total savings of the project Establishment and Operationalization of CCTV Early Warning System (Purchase of 500 units CCTV cameras, servers, software, etc; Construction of CCTV Control/Relay Towers and CCTV Control Rooms-CCTV Command Center and

CCTV Relay Station at Public Market in the amount of Two Million Fifty Nine Thousand Three Hundred Forty One and One centavo (P2,059,341.01), one of the programs/projects under 5% LDRRMF and under the 70% Mitigation Fund, be realigned and same be re-appropriated to cover payment for the proposed project entitled " RELOCATION OF PUBLIC MARKET WIRELESS BASE STATION, ISABELA CITY, BASILAN.

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.


