### **ORDINANCE NO. 21-628**

**ENACTED:** March 24, 2021

**AN ORDINANCE REALIGNING THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00), TAKEN FROM THE APPROVED PROJECT UNDER THE 20% DEVELOPMENT FUND CY 2020 ENTITLED "INSTALLATION/CONSTRUCTION OF CCTV AT PUBLIC MARKET, ISABELA CITY, KAUMPUANAH ZONE I,II AND III, ISABELA CITY, AND TABUK BARANGAY, ISABELA CITY", AND SAME BE RE-APPROPRIATED TO COVER PAYMENT FOR THE PROPOSED PROJECT ENTITLED "TRANSFER OF COMMAND CENTER TO AREA COORDINATING CENTER (ACC) AND INSTALLATION OF CITY-WIDE IP CCTV SECURITY SURVEILLANCE SYSTEM, ISABELA CITY".**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – The amount of **FIVE MILLION PESOS (P5,000,000.00)**, taken from the approved project under 20% Development Fund CY 2020, entitled “Installation/Construction of CCTV at Public Market, Isabela City, Kaumpurnah Zone I, II, and III, Isabela City, and Tabuk Barangay, Isabela City, be realigned and be re-appropriated to cover payment for the proposed project entitled “TRANSFER OF COMMAND CENTER TO AREA COORDINATING CENTER (ACC) AND INSTALLATION OF CCITY-WIDE IP CCTV SECURITY SURVEILLANCE SYSTEM, ISABELA CITY”.

**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.


