A RESOLUTION CONCURRING AND ADOPTING RESOLUTION NO. 4, S. 2021, OF THE EXECUTIVE COMMITTEE, CITY DEVELOPMENT COUNCIL, THIS CITY, APPROVING THE REALIGNMENT OF ONE MILLION SIX HUNDRED SEVENTY FIVE THOUSAND PESOS (P1,675,000.00), FROM THE SAVINGS FOR THE ESTABLISHMENT AND OPERATIONALIZATION OF CCTV EARLY WARNING SYSTEM AND CONSTRUCTION OF CCTV CONTROL/RELAY TOWERS AND CCTV CONTROL ROOMS-CCTV COMMAND CENTER AND RELAY STATION AT PUBLIC MARKET, TO BE UTILIZED IN THE PROPOSED PROJECT FOR THE RELOCATION OF PUBLIC MARKET WIRELESS BASE STATION.

WHEREAS, that there was a total savings in the amount of Two Million Fifty Nine Thousand Three Hundred Forty One Pesos and 01/100 (P2,059,341.01), from the establishment and operationalization of CCTV Early Warning System and Construction of CCTV Control/Relay Station at Public Market;

WHEREAS, the amount of One Million Six Hundred Seventy Five Thousand Pesos (P1,675,000.00), shall be utilized for the Relocation of Public Market Wireless Base Station, Isabela City;

WHEREAS, the City Government of Isabela is mandated to provide effective and efficient governance which are essential to the promotion of the general welfare of its constituents.
