A RESOLUTION CONCURRING AND ADOPTING RESOLUTION NO. 5, S. 2021, OF THE EXECUTIVE COMMITTEE, CITY DEVELOPMENT COUNCIL, THIS CITY, APPROVING THE PROPOSED CONCRETING OF ROADS AND CONSTRUCTION OF BRIDGES, IN THE AMOUNT OF NINE HUNDRED SIXTY FOUR MILLION FOUR HUNDRED THOUSAND PESOS (P964,400,000.00), TO BE FUNDED UNDER SPECIAL PROVISION NO. 3, OF THE LGSF-FA TO LGUs IN RA 11518, FOR THE CITY OF ISABELA AND TO BE INCLUDED IN THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2021.

WHEREAS, LGSF-FA to LGUs shall be exclusively used by the province, cities, municipalities and barangays concerned to fund the eligible programs and projects enumerated under SP No. 3, of the LGSF-FA to LGUs, of the GAA, FY 2021;

WHEREAS, the financial assistance to Local Government Units, shall be utilized to finance projects as enumerated under the Annual Investment Plans for CY 2021;

WHEREAS, among the priority projects of the City Government of Isabela, is the concreting of roads and constructing of bridges that will provide easy access to the constituents of Isabela.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, concurs and adopts Resolution No. 5, S. 2021, of the Executive Committee, City Development Council, this City, approving the Proposed Concreting of Roads and Construction of Bridges, in the amount of Nine Hundred Sixty Four Million Four Hundred Thousand Pesos (P964,400,000.00), to be funded under Special Provision No. 3, of the LGSF-FA to LGUs in RA 11518, for the City of Isabela and to be included in the Supplemental Annual Investment Program, for CY 2021.
