A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITI DJALIA T. HATAMAN, CITY MAYOR, AND MS. MARY JANE R. ABENOJAR, ACTING CITY TREASURER, ALL OF THIS CITY, TO BE THE SIGNATORIES IN THE OPENING OF THREE (3) NEW TRUST FUND ACCOUNTS.

WHEREAS, it is the mandate of the National Housing Authority to meet the needs of the low-income families, focusing its efforts in providing housing needs to the lowest 30% of the urban population;

WHEREAS, Badjao families occupying the foreshore areas along Tampalan Barangay, this City, were chosen as beneficiaries of the Tampalan Badjao IP Housing Project, under the Housing Assistance Program for Indigenous People (HAPIP), of the National Housing Authority, in the amount of Nineteen Million Nine Hundred Ninety-Nine Thousand Two Hundred Fifty Eight and 90/100 (P19,999,258.90) Pesos, to be released by tranches;

WHEREAS, there is a need to open three (3) Trust Fund Accounts for, Diki Badjao IP Housing Project, Carbon Badjao IP Housing Project and Tampalan Badjao IP Housing Project, with the Development Bank of the Philippines, Basilan Branch, with the Honorable Mayor and Acting City Treasurer, all of this City, as signatories.


WHEREFORE, upon motion of Councilor Ma. Jennesa S. Tubongbanua, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, grants authority to Honorable Sitti Djalía T. Hataman, City Mayor, and Ms. Mary Jane R. Abenojar, Acting City Treasurer, all of this City, to be the signatories in the opening of New Trust Fund Accounts.


