## ORDINANCE NO. 21-638

**AN ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION FOUR HUNDRED THIRTY FIVE THOUSAND PESOS (P3,435,000.00), FROM SPECIAL TRUST FUND OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND.**

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present;

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – Realigning the amount of **THREE MILLION FOUR HUNDRED THIRTY FIVE THOUSAND PESOS (P3,435,000.00)**, taken from the Special Trust Fund of the Local Disaster Risk Reduction and Management Fund(LDRRMF), be realigned and same be re-appropriated solely for the purpose of supporting disaster risk

**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.


