WHEREAS, UWARBMPC owns 2 has. of land located at block 6, Purok 8, Menzi, Isabela City, suitable for expansion and development.


NOW WHEREFORE, upon motion of Councilor Abdulkuddus A. Salihin, duly seconded by all members present, **BE IT**
