RESOLUTION GRANTING AUTHORITY TO HER HONOR, THE MAYOR, SITTI DJALIA T. HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF LABOR AND EMPLOYMENT, REGIONAL OFFICE 9, FOR THE IMPLEMENTATION OF THE TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM, PROVIDING TEMPORARY WAGE EMPLOYMENT FOR THE DISPLACED, UNDER-EMPLOYED AND SELF-EMPLOYED WORKERS.

WHEREAS, the Corona Virus Disease 2019 pandemic resulted to community quarantine all over the nation, to lessen the movement of people;

WHEREAS, Ordinance No. 20-577, establishing the guidelines during general quarantine, provides the temporary shut-down of business establishments;

WHEREAS, the precautionary measures being implemented by the City Government Unit of Isabela, in preventing the transmission of the dreaded disease, crippled temporarily some workers from earning;

WHEREAS, several measures were conducted to mitigate the effects that will provide assistance to the affected members of the society, the displaced, under-employed and self-employed workers.

WHEREFORE, upon motion of Councilor Ar-Jhemar K. Ajibon, duly seconded by all members present, **BE IT**

RESOLVED, as is hereby resolved, that the Sangguniang Panlungsod of Isabela, grants authority to Her Honor, the Mayor, Sitti Djalia T. Hataman, this City, to enter into a Memorandum of Agreement (MOA), by and between the City Government of Isabela and the Department of Labor and Employment (DOLE), Regional Office 9, for the implementation of the Tulong Panghanapbuhay sa Ating Displaced/Disadvantaged (TUPAD) Workers Program, providing temporary wage employment for the displaced, under-employed and self-employed workers.
