WHEREAS, Ordinance No. 20-528, provides the reversion and appropriation of certain amount as hazard pay to the City Social Welfare and Development Office, this City.


**NOW THEREFORE**, on motion of Councilor Nida P. Dans, duly seconded by all members present, **BE IT**
