A RESOLUTION COMPELLING MS. AMELITA M. DUMDUM, ACTING CITY BUDGET OFFICER, TO SOURCE OUT FUNDS FROM VARIOUS UNFILLED VACANT POSITIONS OF THE DIFFERENT OFFICES IN THE CITY GOVERNMENT OF ISABELA, FOR THE IMPLEMENTATION OF REPUBLIC ACT 11466 OTHERWISE KNOWN AS THE SALARY STANDARDIZATION LAW OF 2019.

WHEREAS, Local Budget Circular No. 121 dated January 24, 2020, of the Department of Budget and Management provides the implementation of the first tranche of the Modified Salary Schedule in LGUs effective not earlier than January 01, 2020;

WHEREAS, according to the Acting City Budget Officer, the present budgetary situation of the City Government of Isabela does not warrant the implementation of Local Budget Circular No. 121, since allegedly the Local Finance Committee especially the City Treasurer cannot certify for an additional funding source .

WHEREAS, just recently the Budget Officer was able to source out funds coming from the salary savings of unfilled positions for RATA of several Acting Department Heads as evidenced in Ordinance No. 20-582, enacted last May 27, 2020.

NOW WHEREFORE, on motion of Councilor Alan Ritchie B. Biel, duly seconded by all members present, **BE IT**


