Whereas, the city government of Isabela, with almost a population of 120,000 people, does not have its own public cemetery;

Whereas, there is a growing concern particularly from religious sector to set up a public cemetery so that persons, especially those who are financially challenged, will be able to bury their dead loved ones in that particular cemetery;

Whereas, within the bounds of existing laws, the City Mayor may look for available parcel of land which will be used as public cemetery;


NOW WHEREFORE, on motion of Councilor Khaleedsher M. Asarul, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, Province of Basilan, requests her Honor, City Mayor Sitti Djalia T. Hataman, to look into the possibility of establishing a public cemetery and to allocate funds for the construction of the same.
