WHEREAS, the state in its endeavor to address malnutrition among children enacted RA 11037, otherwise known as the "Masustansyang Pagkain para sa mga Batang Pilipino Act of 2018;

WHEREAS, RA 11037 directed the DSWD, in coordination with the LGU's concern to implement supplemental feeding program in day-care centers or in any other facility used for such purpose.


NOW WHEREFORE, on motion of Councilor Sara S. Ismael, duly seconded by all members present, **BE IT**
