A RESOLUTION REITERATING INVITATION TO MS. BARBARA D. MON, ASST. REVENUE DISTRICT OFFICER, OFFICER IN-CHARGE, BUREAU OF INTERNAL REVENUE (BIR), AND MR. RIC MATTHEW GARCIA, DEPARTMENT OF TRADE AND INDUSTRY (DTI), THIS CITY, ON ITS REGULAR SESSION ON JULY 22, 2020, TO UPDATE THE BODY ON THE PROCEDURES OF IMPOSING TAXES TO ONLINE BUSINESSES.

WHEREAS, some businesses now shifted into a small-scale operation through online selling which is now a subject for the imposition of taxes;

WHEREAS, Resolution No. 20-6088, invites any representative from the Bureau of Internal Revenue and Department of Trade and Industry, to update the August Body on the procedures of taxing online businesses;

WHEREAS, during the July 15, 2020, regular session, BIR was not present due to lack of manpower in their office, while DTI was duly represented, but lacks the necessary information and knowledge;
