A RESOLUTION INVITING THE GENERAL MANAGER OF BASELCO, THE HEAD, NATIONAL POWER CORPORATION AND THE HEAD OF AGREKKO, TO ATTEND THE REGULAR SESSION, ON AUGUST 5, 2020, AT 9:00 A.M., TO BE HELD AT THE SANGGUNIANG PANLUNGSOD SESSION HALL, SUNRISE, ISABELA CITY, TO UPDATE THE AUGUST BODY ON THE PRESENT ELECTRICITY SUPPLY OF THE CITY.

WHEREAS, it is the policy of the state and of the local government units to ensure the safety and well-being of its constituents;

WHEREAS, part of the tasks of the Sangguniang Panlungsod is to ensure that the delivery of basic services to the people of Isabela be executed flamboyantly;

WHEREAS, there have been frequent power interruptions and brownouts in the entire Province of Basilan so much so in the City of Isabela over the past weeks;

WHEREAS, the rampant power interruption is causing delays and hassle to business establishments and offices as they are causing inconvenience;

WHEREAS, the Basilan Electric Cooperative (BASELCO) is the sole distributor of electricity in the province of Basilan;

WHEREAS, the National Power Corporation (NPC) is one of the suppliers of electricity in the province of Basilan;

WHEREAS, the AGREKKO is also one of the suppliers of electricity in the Province of Basilan;

WHEREAS, in the exigency of these issues, there is a need to call the attention of electricity suppliers and distributors to shed light on the current status of electricity in the city.

NOW WHEREFORE, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by majority of the members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, invites the General Manager of BASELCO, The Head, National Power Corporation and the Head of AGREKKO, to attend the regular session, on August 5, 2020, at 9:00 a.m., to be held at the Sangguniang Panlungsod Session Hall, Sunrise, Isabela City, to update the August Body on the present electricity supply of the City.
