A RESOLUTION RESPECTFULLY REQUESTING PLTC. HOMER T. DUMALAG, CHIEF OF POLICE, ISABELA CITY POLICE STATION, TO PROVIDE SECURITY CORDON ALONG THE PERIMETER OF THE BAYANIHAN RECEPTION CENTER, LOCATED AT BEGANG, ISABELA CITY.

WHEREAS, it is the policy of the state and of the local government units to ensure the safety and well-being of its constituents;

WHEREAS, due to Covid 19 pandemic, several preventive health measures were being implemented to contain the possible contamination and transmission from the deadly virus;

WHEREAS, several Locally Stranded Individuals (LSIS) and Returning Overseas Filipinos (ROFs), were availing of the Balik Probinsya Program of the government;

WHEREAS, asymptomatic LSIs and ROFs upon arrival, were billeted at the Bayanihan Reception Facility, located at Begang, Isabela City, to undergo the mandatory fourteen (14) days quarantine;

WHEREAS, to effect the essence and the true purpose of the quarantine, a security cordon 20-25 mts. from the perimeter walls, shall be established and to be manned by PNP personnel, to be assisted by barangay tanods, CVOs and CAFGUs, to ensure the full protection and general welfare of the constituents.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by majority of the members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguiang Panlungsod of Isabela, respectfully requests PLTC. Homer T. Dumalag, Chief of Police, Isabela City Police Station, to provide security cordon along the perimeter of the Bayanihan Reception Center, located at Begang, Isabela City.
