WHEREAS, upon pronouncement of the Department of Education, Manila, classes will be opening on August 24, 2020, under the new normal;

WHEREAS, our Bayanihan Reception Center, used in billeting asymptomatic individuals undergoing the fourteen (14) days quarantine, is located at Begang National School, might be needed in the opening of classes;

WHEREAS, there is a need to look for another possible viable facility that can house testing laboratories, isolation and probably quarantine facility that will

serve as an alternative facility in case the present reception center located at Begang National High School will be transferred because of the opening of classes;

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by majority of the members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguiang Panlungsod of Isabela, respectfully requests Engr. Joseph A. Lazaro, Acting City Engineer in coordination with Dr. Mohrein H. Ismael VI, City Health Officer and Mr. Jaime Juanito A. Rivera, Acting CDRRM Officer, all of this City, to look for another viable facility to be utilized in our fight against Corona Virus Disease 2019.
