WHEREAS, the pandemic is far-away to its end putting any local government unit into a critical situation in sustaining its present programs in their fights against Covid 19.


NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by majority of the members present, **BE IT**
