A RESOLUTION DISMISSING ADMINISTRATIVE CASE NO. 02-2020, ALANO VERSUS FOJAS, ET. AL., FOR REFUSAL TO ENFORCE THE LAW, VIOLATION OF RA 6713, IRREGULAR ACTS AND BIASES IN FAVOR OF RESPONDENTS, FOR LACK OF MERIT.

WHEREAS, an administrative complaint was filed by Ms. Patricia Ellen Alano-de Jesus against Hon. Lilibeth T. Fojas, Punong Barangay, Mr. Teofilo A. Carbonilla, Lupon, Ms. Susan de Lima, Purok Leader and Hon. Jeng Pineda, Kagawad, all of Doña Ramona Barangay, for Refusal to Enforce the Law, Violation of RA 6713, Irregular Acts and Biases in Favour of Respondents, with the Office of the Sangguniang Panlungsod, this City, docketed as Administrative Case No. 02-20;

WHEREAS, both parties were allowed to present their statements and documents in a committee hearing conducted by the joint Committees on Good Governance and Public Ethics, Natural Resources and Environmental Protection and Barangay Affairs, Sangguniang Panlungsod, this City, cross-examining all allegations;

WHEREAS, the following grounds of complaints were discussed one-by-one by the joint committees, weighing all presentations and supporting documents from both parties;

NOW WHEREFORE, upon motion of Councilor Candu I. Muarip, duly seconded by all members present, **BE IT**


