HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU), BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, IN THE IMPLEMENTATION OF THE TEN CYCLE SUPPLEMENTAL FEEDING TO THE DAY CARE CHILDREN OF ISABELA CITY.

WHEREAS, Republic Act No. 11037 or the Masustansyang Pagkain Para sa Batang Pilipino Act, provides for the effective and efficient implementation of the National Feeding Program for Public Day Care Center (PDCC);

WHEREAS, the Supplementary Feeding Program is part of the Early Care Development program of the government which is being implemented by the Department of Social Welfare and Development;

WHEREAS, the implementation of the national feeding program shall sustain the gains of good nutrition through the delivery of the early childhood care and development services consistent with RA 10410, otherwise known as the Early Years Act of 2013.


NOW WHEREFORE, on motion of Councilor Sara S. Ismael, duly seconded by all members present, **BE IT**
