A RESOLUTION RESPECTFULLY REQUESTING PNP REGION-IX, TO UPGRADE POLICE STATION OF THE CITY OF ISABELA, INTO A SPECIAL TYPE "A" CITY POLICE STATION.

Whereas, it is the policy of the state and of the local government units to ensure the safety and welfare of its citizens;

Whereas, as stipulated under Sec. 458 (1) (ii) of RA 7160, otherwise known as the Local Government Code of the Philippines, the Sangguniang Panlungsod shall enact ordinances and approve resolutions which will "maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion, or sedition...";

Whereas, the Police Regional Office 9 is recommending, among 3 others, Isabela City Police Station to be considered as Special Type "A" CPS in order to sustain the government's efforts at intensifying security measures and proactively deter the spillover of terrorism and violent extremism, repression of prevalent crimes, entry of illegal drugs, smuggling and other crimes of such magnitude.;

Whereas, the salient features of the proposed reorganization and restructuring of Isabela City Police Station are as follows:

- (a.) Upgrading the rank of Chief of Police from Police Lieutenant Colonel to Police Colonel;
- (b.) Increase in the authorized complement of the City Police Station;
- (c.) Creation of Mobile and Seaborne Patrol Unit under the Operations Section composed of four 8-man patrol teams;
- (d.) Provision of nine-man EOD/K9 Team (to be detailed from the PNP-EOD/K9 Group and placed under the operational control of the Chief of Police; and,
- (e.) Provision of five standard 55-man Police-Community Precincts (PCPs);

Whereas, there is a need to upgrade the current Isabela City Police Station into a Special Type "A" City Police Station to bolster the security efforts of the City Police Station.

NOW WHEREFORE, on motion of Councilor ALAN RITCHIE LUIS B. BIEL, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, requests PNP Region-IX to upgrade Police Station of the City of Isabela, into a special type "A" City Police Station.
