WHEREAS, Dito Telecommunity Corporation is formerly known as the Mindanao Islamic Telephone Company (MISLATEL), is a telecommunications company in the Philippines, owned by Davao-based businessman Dennis A. Uy, of Udenna Corp.;

WHEREAS, on July 8, 2019, President Rodrigo R. Duterte, awarded Mislattel Consortium, now Dito Telecommunity the permit to operate as the Philippines' third telco provider, through a House Bill granting a 25-year franchise;

WHEREAS, the emerge of a third telco will provide the opportunity of healthy competitions among telecommunications company thereby results to a more better services;
