**A RESOLUTION RESPECTFULLY REFERRING TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) FOR PROPER LEGAL ACTION, THE COMPLAINT OF THE PRESIDENT OF THE MANGROVE ASSOCIATION OF TABIAWAN KAGAWAD ALBERTO S. JAYSON OF TABIAWAN BARANGAY, ON MATTER INVOLVING THE ILLEGAL CUTTING OF MANGROVE IN THE MANGROVE SWAMP FOREST RESERVE IN TABIAWAN BARANGAY, THIS CITY.**

**WHEREAS**, the Sangguniang Panlungsod of Isabela received on September 28, 2020 a verified complaint with attachments of Kagawad Alberto S. Jayson detailing the alleged illegal cutting of mangrove in the Tabiawan Mangrove Swamp Forest Reserve by alleged individuals;

**WHEREAS**, during a meeting conducted by the SP Committee on Natural Resources and Environmental Protection , while coordination among agencies have been agreed, the complaint of Mr. Jayson needed to be substantiated by proof beyond reasonable doubt of the act complained of to stand prosecution in the court of law;

**WHEREAS**, the DENR is the appropriate agency to facilitate the prosecution of the alleged illegal of mangrove in the Tabiawan Mangrove Swamp Forest Reserve, however, the LGU of Isabela City with the combined efforts of the Committee on Natural Resources and Environmental Protection, the City Agriculture Office, Barangay Tabiawan and Baluno and other agencies will render collaborative acts to curtail or minimize the illegal cutting of mangroves in the said area.

After due deliberation on the matter, on motion of Councilor Abdulkuddus A. Salihin, duly seconded by all members present, **BE IT**

**RESOLVED**, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, refers to the Department of Environment and Natural Resources (DENR) for proper legal action, the complaint of the president of the Mangrove Association of Tabiawan kagawad Alberto S. Jayson of Tabiawan Barangay, on matter involving the illegal cutting of mangrove in the mangrove swamp forest reserve in Tabiawan Barangay, this City.
