A RESOLUTION CONCURRING AND ADOPTING CDC RESOLUTION NO. 9, S. 2020 ENTITLED " A RESOLUTION APPROVING THE PROPOSED PROJECTS IN THE AMOUNT OF PHP 30,000,000.00 FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND (LGSF) COVID-19 FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGU'S) IN THE BAYANIHAN TO RECOVER AS ONE ACT".

WHEREAS, it is the policy of the state and of the local government units to provide services that will ensure the well-being of its constituents;

WHEREAS, the Isabela City Development Council is the City Development Council of the City of Isabela tasked to formulate development plans and policies as stipulated under Sec. 109, Title Six of RA 7160, otherwise known as the Local Government Code of the Philippines;

WHEREAS, the City Development Council Executive Committee (CDC-ExeComm) convened last October 12, 2020;

WHEREAS, the CDC ExeComm was convened in response to the DBM LBC No. 128 dated September 1, 2020 which provides for the guidelines on the release and utilization of the Local Government Support Fund (LGSF) – COVID19 Financial Assistance to Local Government Units (LGUs) as stipulated under RA 11494, otherwise known as the Bayanihan to Recover As One Act.

WHEREAS, pursuant to DBM LBC, the City Government of Isabela was able to identify priority projects as response and recovery intervention to COVID 19;

WHEREAS, after careful deliberation and study, the CDC ExeCom has approved the proposed projects in the amount of Thirty Million Pesos (Php 30,000,000) under the Local Government Support Fund (LGSF)

WHEREAS, in accordance under existing laws, the said resolution needs concurrence of the City Council.


After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, concurs and adopts Resolution No. 9, s. 2020, " A Resolution approving the Proposed projects in the amount of PHP 30,000,000.00 funded under the Local Government Support Fund (LGSF) Covid-19 financial assistance to Local Government Units (LGU's) in the Bayanihan to recover as one act.
