**Whereas,** It is the policy of the state and of the local government units to ensure the safety and welfare of its people;

**Whereas,** Section 6 of RA 7883 otherwise known as " An Act granting benefits and incentives to accredited barangay health workers and for other purposes" provides that, " In recognition of their services, all accredited barangay health workers who are actively and regularly performing their duties shall be entitled to incentives and benefits";

**Whereas,** during this Covid-19 Pandemic, many if not all, volunteer barangay health workers in rural and urban centers are exposed to conditions,

or factors in the work environment where foreseeable but unavoidable risks which can adversely endanger his health or life and /or increase the risk of producing adverse effect on his person in the exercise of his duties due to the viral contamination;

**Whereas,** there are approximately 250 volunteer health workers fielded in our 45 barangays which maybe categorized as frontliners in the fight against Covid-19 are receiving meager monthly allowance;

**Whereas,** month of December is a season of giving it is just but fitting that our volunteer health workers, who selflessly provide basic, safe and effective health care services to the residents in the barangay, be accorded the dignity of recognition for their services.


**WHEREFORE,** upon motion of Councilor Haizer A. Salain, duly seconded by all members present, **BE IT**
