A RESOLUTION REQUESTING THE REGIONAL DIRECTOR, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, TO FURNISH THE SANGGUNIANG PANLUNGSOD OF ISABELA, A CERTIFIED TRUE-COPY OF THE CADASTRAL MAP/SURVEY ON THE BOUNDARIES OF THE FORTY-FIVE (45) BARANGAYS, THIS CITY.

WHEREAS, the Department of Environment and Natural Resources (DENR) and the Philippine Statistics Authority (PSA), conducted a survey on barangay boundaries on the forty-five (45) barangays in the City;

WHEREAS, a private surveying firm from Manila, was commissioned to undergo the said survey, utilizing the old cadastral map of Isabela;

WHEREAS, the result of said survey created confusion and conflict among the barangays as boundaries and geographical territory were in question;

WHEREAS, the conflicts were later settled with the new cadastral map, showing the true and correct barangay boundaries;

WHEREAS, the new cadastral map of Isabela City, is a requisite in the amendment of Ordinance No. 94-005, Delineating the Barangay Boundaries of Isabela, which is now pending in the Sangguniang Panlungsod of Isabela, prior to the submission of pertinent documents.

NOW WHEREFORE, on motion of Councilor Ar-Jhemar K. Ajibon, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, requests the Regional Director, Department of Environment and Natural Resources, to furnish the Sangguniang Panlungsod of Isabela, a certified true-copy of the cadastral map/survey on the boundaries of the forty-five (45) barangays, this city.
