A RESOLUTION RESPECTFULLY REQUESTING THE CHIEF OF POLICE, ISABELA CITY POLICE STATION, TO PROVIDE POLICE VISIBILITY AND ALL THE FORTY-FIVE (45) PUNONG BARANGAYS, TO BE ON A HEIGHTENED ALERT STATUS AND TO ACTIVATE THEIR TANODs AND CVOs, IN PROVIDING SECURITY IN THEIR RESPECTIVE BARANGAYS.

WHEREAS, subscribers of the different telecommunication companies in Basilan Province, particularly Isabela City, is suffering from slow to medium connectivity with internet;

WHEREAS, with the new-normal in our educational system, students need to connect to the internet in order to attend their online classes;

WHEREAS, with the present of internet connectivity in Isabela City, students were in search of a good spot with a strong internet connections that includes secluded areas that are favorable to the commission of bad acts or commission of crimes;

WHEREAS, there was an incident in Baluno Barangay, this City, wherein a young girl who became a victim of an act of lasciviousness from two (2) unidentified men riding in tandem who stopped in front of her and forcibly dragged her towards a secluded place;

WHEREAS, the victim cried for help which called the attention of male teenagers nearby that drove away the suspects, with such act also endangered the life of both the victim and those who helped.

WHEREAS, police visibility and the presence of tanods and CVOs in all areas of responsibility of their respective barangays will secure and will provide protections to their constituents.

NOW WHEREFORE, upon motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, respectfully requests the Chief of Police, Isabela City Police Station, to provide police visibility and all the forty-five (45) punong barangays, to be on a heightened alert status and to activate their tanods and CVOs, in providing security in their respective barangays.
