A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITI DJALIA TURABIN-HATAMAN, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF TOURISM, REGION 9, IN THE IMPLEMENTATION OF THE DOMESTIC TOURISM PROJECTS IN THE CITY OF ISABELA.

WHEREAS, the Department of Tourism 9 shall release and transfer to the Local Government Unit of Isabela, the amount of Four Million Four Hundred Fifty Thousand Pesos (P4,450,000.00), for the implementation of the Domestic Tourism Projects of the City of Isabela;

WHEREAS, the said amount shall be exclusively use in the implementation of the Domestic Tourism Projects and realignment of unutilized funds is strictly prohibited;

WHEREAS, the Local Government Unit shall implement the Domestic Tourism Projects in accordance with the direction of DOT-9 and shall provide report on the status of its implementation;

WHEREAS, both parties shall comply with the Commission on Audit on the Rules and Regulations in the grant and utilization of funds transferred to implementing agencies.

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod, this City, grants authority to Her Honor, Mayor Sitti Djalia Turabin-Hataman, this City, to enter into a Memorandum of Agreement (MOA), by and between the City Government of Isabela and the Department of Tourism, Region 9, in the implementation of the Domestic Tourism Projects, In The City Of Isabela.
