A RESOLUTION REQUESTING THE BASILAN ELECTRIC COOPERATIVE (BASELCO) AND AGGREKO, TO SUBMIT TO THE SANGGUNIANG PANLUNGSOD OF ISABELA, A WRITTEN REPORT ON THEIR POWER SERVICES AND UNSCHEDULED POWER INTERRUPTIONS, IN THE CITY OF ISABELA.

WHEREAS, BASELCO and NAPOCOR explained previously that power interruptions and power outages were caused by dilapidated and congested distribution lines;

WHEREAS, renovations and regular maintenance were conducted by BASELCO and NAPOCOR to improve their services being catered to the Isabeleños;

WHEREAS, recently, unscheduled power interruptions are being experienced in the City of Isabela which brings not only discomforts to the populace but also a loss of the most in the business sectors.

NOW WHEREFORE, upon motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by all members present, **BE IT**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, request Basilan Electric Cooperative (BASELCO) and Aggreko, to submit to the Sangguniang Panlungsod of Isabela, a written report on their power services and unscheduled power interruptions, in the City of Isabela.
