AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION TWO HUNDRED THOUSAND (P2,200,000.00) PESOS, AS AUGMENTATION APPROPRIATION FOR THE CONSTRUCTION OF MARKING THE PHILIPPINE ROUTE OF THE FIRST CIRCUMNAVIGATION OF THE WORLD, AT TABIAWAN BARANGAY, THIS CITY, TO BE TAKEN FROM THE APPROPRIATION FOR THE CONSTRUCTION OF A CANOPY WALK, LOCATED AT MALIGUE BARANGAY, THIS CITY, IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00).

After due deliberation on the matter, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present; BE IT

Ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, THAT:

SECTION 1. - The amount of TWO MILLION TWO HUNDRED THOUSAND (P2,200,000.00) PESOS, shall be an augmentation appropriation for the


construction of Marking the Philippine Route of the First Circumnavigation of the World, at Tabiawan Barangay, this City, to be taken from the appropriation for the construction of a Canopy Walk Project, located at Maligue Barangay, this City, in the amount of Ten Million (P10,000,000.00) Pesos, , be re-aligned and same be re-appropriated to augment the appropriation for the the construction of Marking the Philippine Route of the First Circumnavigation of the World, at Tabiawan Barangay, this City.

**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.
