AN ORDINANCE AMENDING SECTION 10(b), ONE-WAY STREETS, OF ORDINANCE NO. 03-143, OTHERWISE KNOWN AS THE TRAFFIC CODE OF THE CITY OF ISABELA, TEMPORARILY CLOSING RIZAL AVENUE, FROM THE JUNCTION OF JS ALANO STREET TO THE JUNCTION OF N. VALDERROSA STREET, FROM JUNE 24 TO JULY 24, 2021.

WHEREAS, the City Government of Isabela, will be undertaking an infrastructure development along the area of Rizal Avenue, which affects particularly the road between the City Plaza and Plaza Rizal;

WHEREAS, there is a need for the temporary closure of the said road to ascertain the viability of the proposed implementation of the City Plaza and Plaza Rizal Improvement Project;

WHEREAS, the temporary closure will provide safety both the pedestrians and the contractor during the implementation of the said improvement project.

ORDAINED, by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, **THAT**:

SECTION 1. – Section 10(b), ONE-WAY STREETS, of Ordinance No. 03-143, otherwise known as the Traffic Code of Isabela City, is hereby amended, temporarily closing portion of Rizal Avenue, from the junction of JS Alano Street to the junction of N. Valderrosa Street, from June 24 to July 24, 2021.

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.


