AN ORDINANCE REALIGNING THE AMOUNT OF ONE HUNDRED NINETEEN THOUSAND SIX HUNDRED THIRTY EIGHT PESOS (P119,638.00), TAKEN FROM SALARIES OF VACANT POSITIONS UNDER OFFICE OF THE CITY HEALTH, THIS CITY, FOR PAYMENT OF TERMINAL LEAVE BENEFITS OF THE LATE MR. 
Thousand Six Hundred Two Pesos (P14,602.00); Midwife I, in the amount of Sixteen Thousand Six Hundred Fifty Four Pesos (P16,654.00); Midwife IV, in the amount of Twenty Eight Thousand Five Hundred Thirty Nine Pesos (P28,539.00); Midwife III, in the amount of Twenty Four Thousand Thirty Five Pesos (P24,035.00); Sanitation Inspector III, in the amount of Twenty Thousand Two Hundred Ninety Five Pesos (P20,295.00); Sanitation Inspector I, in the amount of Fifteen Thousand Five Hundred Thirteen Pesos (P15,513.00), be realigned and same be re-appropriated for the payment of Terminal Leave benefits of the late Mr. Abdulgani J. Dundain, Dental Aide I, Office of the City Health, this City.

SECTION 2. - Effectivity - This Ordinance shall take effect upon its approval.




