A RESOLUTION RESPECTFULLY REQUESTING HER HONOR SITTI DJALIA HATAMAN-TURABIN, CITY MAYOR, THIS CITY, TO INCLUDE IN THE ANNUAL GENERAL FUND BUDGET CY 2022, AN ALLOCATION UNDER 20% DEVELOPMENT FUND FOR THE ESTABLISHMENT OF A SPRING SOURCE WATER SYSTEM IN BARANGAY KAPAYAWAN.

**WHEREAS**, it is the responsibility of the state and of the Local Government Units that the basic social services will be felt and delivered to the people most especially those living in far-flung areas;

**WHEREAS**, the people of Barangay Kapayawan, an upland barangay in the City of Isabela, has been enduring years of no stable water distribution system;

**WHEREAS**. There are currently no direct connection from the local water district at Barangay Kapayawan due to its location;

WHEREAS, residents of Barangay Kapayawan are struggling to have access to safe and potable water as they still need to go to the nearest water station which is almost 5 kilometers away from the barangay poblacion; **WHEREAS**, There are a lot of water sources in Barangay Kapayawan but the residents need equipment and materials in order to properly distribute the water coming from these sources into their respective households.

**WHEREAS**, the Barangay Local Government Unit of Kapayawan do not have the enough budgetary requirements in order to construct a water distribution system in their barangay;

**WHEREAS**, there is a need for the City Government of Isabela to look into this matter in order for the residents of Barangay Kapayawan to finally have a safe and potable water distribution system;

**WHEREFORE**, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BEIT** 

**RESOLVED**, as is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, requests her Honor Sitti Djalia Turabin-Hataman, City Mayor, this City, requests her Honor Sitti Djalia Turabin-Hataman, to include in the Annual general Fund Budget, CY 2022, an allocation under 20% Development Fund for the establishment of a Spring Source Water System in Barangay Kapayawan.
