A RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR-IX) TO LOOK INTO THE POSSIBILITY OF CONDUCTING A RESURVEY OF THE CITY AND BARANGAY BOUNDARY MAP OF ISABELA AS CONTAINED IN THE CADASTRAL SURVEY OF 2017 WHICH WILL RESOLVE THE BARANGAY BOUNDARY DISPUTES.

WHEREAS, the recent Cadastral Survey of 2017 was conducted purposely to determine the barangay boundaries in the City;

WHEREAS, upon receipt of the Cadastral Survey, it was found out that there are disputed barangay boundaries that were not resolved by the said survey and has since remained as "disputed" or "contested" areas;

WHEREAS, the said confusion further slowed down the progress on the proposed revision of Ordinance Delineating Barangay Boundaries of the City of Isabela;

WHEREAS, there is a need for the Department of Environment and Natural Resources, as the main agency tasked to conduct the Cadastral Survey, to resurvey the barangay boundaries particularly those barangays with disputed boundaries.


NOW WHEREFORE, upon motion of Councilor Abdulkuddus A. Salihin, duly seconded by all members present, **BE IT**

RESOLVED, that the Sangguniang Panlungsod of Isabela, Province of Basilan, respectfully requests the Department of Environment and Natural Resources (DENR), Region IX, through the Regional Executive Director, Crisanta Marlene P. Rodriguez, seeking advice for possible resurvey of the City Boundary Index Map of Isabela, contained in the Cadastral Survey of 2017, which will finally resolve the contested Barangay Boundary Disputes.
