**A RESOLUTION RESPECTFULLY REQUESTING HONORABLE SITI DJALIA TURABIN-HATAMAN, CITY MAYOR, THIS CITY, IMPLORING HER HONOR TO PRESCRIBE FUNDS FOR THE CONSTRUCTION OF BARANGAY HALL FOR BARANGAY LUMBANG, AND TO INCLUDE THE PROPOSED PROJECT IN THE LIST OF PRIORITY PROJECTS TO BE FUNDED UNDER THE 2022 ANNUAL GENERAL FUND BUDGET UNDER THE 20% DEVELOPMENT FUND OF THE PROPOSED ANNUAL GENERAL FUND.**


**WHEREFORE**, on motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**


