**A RESOLUTION AUTHORIZING HER HONOR, MAYOR SITI DJALIA A. TURABIN-HATAMAN TO CLOSE THE REGULAR SAVINGS ACCOUNT OF THE THREE ACCOUNTS INTENDED FOR THE NATIONAL HOUSING AUTHORITY – HOUSING PROJECT, AND TO ALLOW HER HONOR TO OPEN A NEW AND CORRECT CURRENT ACCOUNT FOR THE SAME PURPOSE.**

**WHEREAS**, The Sangguniang Panlungsod of the City of Isabela has passed resolution no. 2021-0000 entitled "A RESOLUTION GRANTING AUTHORITY TO HONORABLE SITI DJALIA T. HATAMAN, CITY MAYOR, AND MS. MARY JANE ABENOJAR, ACTING CITY TREASURER, ALL OF THIS CITY, TO BE SIGNATORIES IN THE OPENING OF THREE (3) NEW TUST FUND ACCOUNTS."

**WHEREAS**, upon approval of the said resolution, accounts were already opened for the above-mentioned purpose, to wit:

1. CITY GOVERNMENT OF ISABELA TF DIKI BADJAO with account number 5-12720-905-2;
2. CITY GOVERNMENT OF ISABELA TF CARBON BADJAO with account number 5-12721-905-7; and

3. CITY GOVERNMENT OF ISABELA TF TAMPALAN BADJAO with account number 5-12722-905-1

**WHEREAS,** A letter was submitted to the honorable members of the Sangguniang Panlungsod dated August 2, 2021 from Ms. Mary Jane F. Abenojar, Acting City Treasurer, City of Isabela informing the honorable members that the accounts that were opened were placed as "savings account" with the Development Bank of the Philippines which is not applicable to Local Government Units as the LGUs are not allowed to maintain a savings account;

**WHEREAS,** There is a need for the City Government of Isabela to close the above-mentioned savings accounts and to open a new and correct account;


**NOW, THEREFORE,** On motion of Councilor Alan Ritchie Luis B. Biel, duly seconded by all members present, **BE IT**
