Whereas, the honorable members of the Sangguniang Panlungsod deemed it fitting and proper to concur with the above-mentioned resolution of Barangay Makiri;


Now wherefore, on motion of Hon. Alan Ritchie Luis B. Biel, duly seconded by all members of the council present, be it


