WHEREAS, It is the policy of the state and of the local government units to ensure the safety and well-being of its citizens,

WHEREAS, The Isabela City Police Station – the lead police agency in the city of Isabela, is currently under the stewardship of Police Lieutenant Colonel (PLtCol) Junpikar Sitin;

WHEREAS, PLtCol Sitin, since his assumption into the office as the Acting Chief of Police of the Isabela City Police Station, has been exerting efforts to maintain and secure the peace and order in the city and has ensure the safety and well-being of the people of Isabela particularly during this time of pandemic;

WHEREAS, under his stewardship, he was able to lead a strong, 163-police force which ensures a safety and orderly Isabela City;
