**REORGANIZATION OF THE BARANGAY PEACE AND ORDER COMMITTEE (BPOC)  
EVALUATION TASK FORCE OF ISABELA CITY, PROVINCE OF BASILAN**

**WHEREAS**, the Philippine Constitution mandates the government to promote the quality of life of the people, and Section 16 of the 1991 Local Government Code provides that LGUs shall within their territorial jurisdictions, promote health and safety, improve morals, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, RA No. 6975 mandates the DILG to promote peace and order and public safety and capacitate LGUs including the barangays for the effective delivery of basic services;

**WHEREAS**, EO No. 366 dated September 1996 requires all barangays to organize the BPOCs that will serve as the implementing arm of the city in the implementation of peace and order and public safety programs;

**WHEREAS**, Section 11 of the National Peace and Order Council (NPOC) Memorandum Circular No. 2002-05 dated June 24, 2002 directs the DILG to monitor the functionality of the BPOCs, and that DILG Memorandum Circular No. 2008-101 dated June 17, 2008 provides the guidelines in monitoring the functionality of BPOCs.

**NOW, THEREFORE, I, SITTI DJALIA T. HATAMAN**, City Mayor of Isabela City, Province of Basilan, by virtue of the power vested in me by law, do hereby **ORDER**:

**Section 1. CREATION BARANGAY PEACE AND ORDER COMMITTEE (BPOC)  
EVALUATION TASK FORCE.**

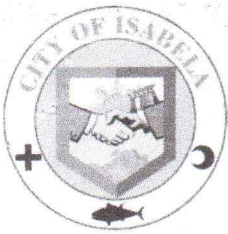

**Section 2. DUTIES AND FUNCTIONS OF THE BARANGAY PEACE AND ORDER COMMITTEE (BPOC) EVALUATION TASK FORCE.**

The **BPOC EVALUATION TASK FORCE** shall have the following duties and functions:

- 1) Assess the functionality of the 45 BPOCs of Isabela City based on the submitted barangay self-assessment form within the prescribed assessment period, and every year thereafter;
- 2) Review/evaluate the means of verification (MOVs) and relevant documents for assessment of BPOC Functionality;
- 3) Conduct validation activities whenever necessary;
- 4) Submit consolidated monitoring report and assessment results to the DILG Isabela City Office.

**Section 3. FUNDING SUPPORT.**

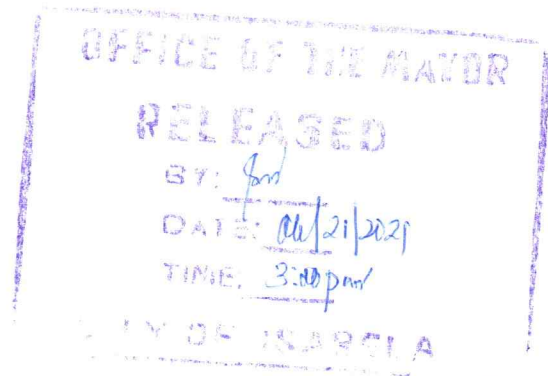
Funding support for the conduct of the foregoing assessment shall be charged to the Office of the City Mayor.
