**A RESOLUTION GRANTING AUTHORITY TO HER HONOR, MAYOR SITI DJALIA A. TURABIN-HATAMAN TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE CITY GOVERNMENT OF ISABELA AND THE DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE IX, IN RELATION TO THE TULONG PANGKABUHAYAN SA ATING DISPLACED/DISADVANTAGED WORKERS (TUPAD) PROGRAM OF THE DEPARTMENT OF LABOR AND EMPLOYMENT.**

**Whereas,** Sec. 455 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines states that local chief executives shall “represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;”;

**Whereas,** a letter was forwarded to the honorable members of the Sangguniang Panlungsod dated September 6, 2021 of her honor, Mayor Sitti Djalia A. Turabin-Hataman and was received by the Office of the Sangguniang Panlungsod requesting the honorable members to pass a resolution granting authority to her honor to enter into a Memorandum of Understanding by and between the City Government of Isabela and Department of Labor and Employment – Regional Office IX;

- Whereas,** the said Memorandum of Agreement is in relation to Tulong Pangkabuhayan sa Ating Displaced/Disadvantaged Workers (TUPAD) Program of the Department of Labor and Employment;
- Whereas,** the said program provides assistance to help displaced or to be displaced workers in coping with the closure or slowing down of operations of companies as a result of economic disruption and/or the occurrence of natural disasters, calamities, or armed conflicts that affect their economic base and to augment the meager income of the underemployed and seasonal workers;
- Whereas,** the said program will enable the displaced workers, underemployed and seasonal workers to engage in short-term community works to provide them with temporary wage employment for a period of ten (10) days;
- Whereas,** the said program will greatly benefit the marginalized workers of the City of Isabela particularly the underemployed and seasonal workers and thus, the said authority is hereby needed by the Local Chief Executive;


**NOW, THEREFORE,** on motion of Councilor Karel Annjaiza R. Sakkalahul, duly seconded by all members present, be it

**RESOLVED,** as it is hereby resolved, that the Sangguniang Panlungsod of the City of Isabela, authorizes Her Honor, Mayor Sitti Djalia A. Turabin-Hataman to enter into a Memorandum of Understanding, by and between the City Government of Isabela and the Department of Labor and Employment – Regional Office IX, in relation to the Tulong Pangkabuhayan Sa Ating Displaced/Disadvantaged Workers (TUPAD) program of the Department of Labor and Employment
