A RESOLUTION RESPECTFULLY REQUESTING THE OFFICE OF CONGRESSMAN MUJIV HATAMAN, DEPUTY SPEAKER OF THE HOUSE OF REPRESENTATIVE, TO LOOK INTO THE POSSIBILITY OF ALLOCATING FUNDS FOR THE CONSTRUCTION OF ONE SCHOOL BUILDING INTENDED FOR SUMAGDANG ELEMENTARY SCHOOL

WHEREAS, the right to education is a fundamental right in the Philippines;

WHEREAS, Article XIV Section I (Education) of the 1987 Constitution of the Republic of the Philippines provides that, "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all.";

WHEREAS in the past few years, there has been an increase in the number of students enrolling in Sumagdang Elementary School;

WHEREAS, some classrooms of this school are already dilapidated while some, despite major renovations, have consistently been causing inconvenience both for teachers and learners;

WHEREAS, there is a need to allocate funds for the construction of a school building intended for Sumagdang Elementary School;

NOW WHEREFORE, upon motion of Councilor Haizer A. Salain, duly seconded by all members present, **IT WAS**

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of Isabela, Province of Basilan, respectfully requesting the Office of Congressman Mujiv hataman, Deputy Speaker of the House of Representative, to look into the possibility of allocating funds for the construction of one school building intended for Sumagdang Elementary School.
