**AN ORDINANCE REALIGNING THE AMOUNT OF TWO HUNDRED NINETY TWO THOUSAND FIVE HUNDRED SIXTY PESOS (P292,560.00), TAKEN FROM THE APPROPRIATION BALANCE UNDER MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE), BE REALIGNED AND RE-APPROPRIATED AS LGU SHARE ON CULTURAL MAPPING OF THE CITY OF ISABELA UNDER OTHER MAINTENANCE AND OPERATING EXPENSES, OFFICE OF THE CITY TOURISM, THIS CITY.**

Be it ordained by the Sangguniang Panlungsod of the City of Isabela, Province of Basilan, that:

**Section 1.** – Realigning the amount of **TWO HUNDRED NINETY TWO THOUSAND FIVE HUNDRED SIXTY PESOS (P292,560.00)**, taken from the appropriation balance of the following under Maintenance and other operating



**SECTION 2.** - Effectivity - This Ordinance shall take effect upon its approval.


